# Music Department Fall Candy Bar Sales - Road to Anaheim

To start us on the road to Anaheim, we will be selling See's Candy Bars beginning October 17th and ending on November 4th. Students & chaperones who wish to sell candy to off-set their Anaheim trip can participate in the following ways.

1) Sell candy on their own: Each box of candy contains 24 assorted bars (8 each Milk Chocolate, Dark Chocolate with Almonds & Milk Chocolate with Toffee) priced at \$2.00 each ( total of \$48.00 per box). We make 50% of sales price. That 50% will be deposited into your Anaheim account. **Once you check out a box of candy YOU ARE RESPONSIBLE for selling the whole box. Partial boxes/individual bars cannot be returned. YOU ARE ALSO RESPONSIBLE for turning in ALL money associated with your candy sold or not.**

Participants can pick up their box(es) of candy on **Monday, October 17th and Tuesday, October 18th** after school in the Music Room.  
\*\*Money must be turned in for all candy sales by November 4th to be placed into your Anaheim account. Please be sure all money returned in the envelope provided. Please be sure the envelope is SEALED with your name on it.

2) We will be holding sales opportunities for students & chaperones to sell "music candy"(this is candy that is NOT CHECKED OUT TO A SPECIFIC STUDENT OR CHAPERONE) Local merchants have given us permission to sell candy in front of their stores on specific dates and times. The sales from candy sold will be divided amongst those students/chaperones based on the time they work the event.

**Example:** Elizabeth Jones and her parent/chaperone Cindy Jones along with four(4) others sign up to sell candy in front of our local merchant on Saturday from 9am-Noon (3 hours) and during that time they sell Eight (8) dozen (96) candy bars x \$2.00 =\$192 We make 50% of sales. So,our profit is \$96 this amount will be divided between Elizabeth, Cindy and the four other participants.
