FY 2024-25 1st Interim Certification

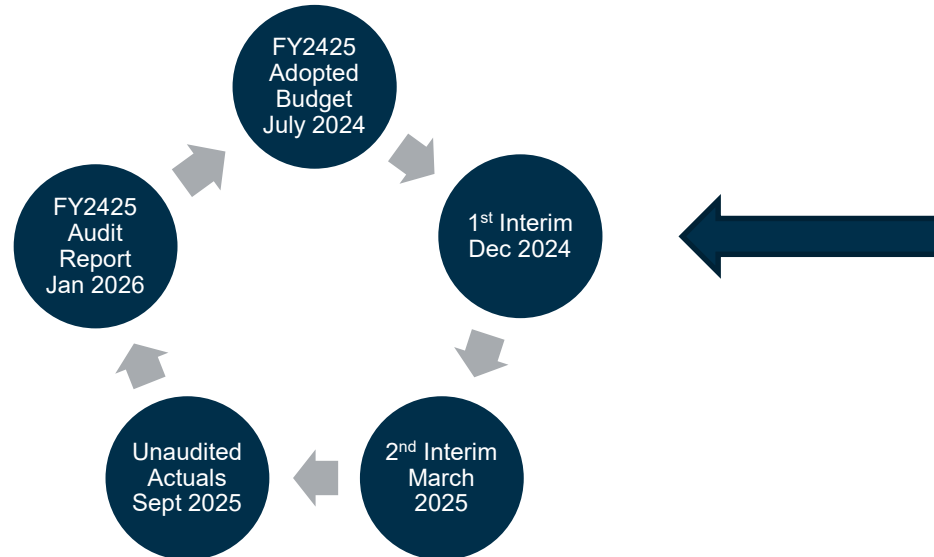


- The First Interim Report represents the District's first official revision to the Adopted Budget includes actual financial data through October 31, 2024 with revised projections through the remainder of the fiscal year.
- The District must certify its financial condition with each Interim Report.
- Positive – meets financial obligations for current and two subsequent fiscal years.
- Qualified – may not be able to meet financial obligations for current and two subsequent fiscal years.
- Negative – will be unable to meet its financial obligations for current and two subsequent fiscal years

2024 -25 Budget Cycle



- California Education Code, 42130 and 42131 require that interim reports to be submitted to the governing board on the Standard Account Code structure forms, which is the format prescribed by the Superintendent of Public instruction.

Introduction:

The Executive Summary is an overview of the financial data reported in the Standardized Account Code Structure (SACS), Second Interim Report for Fiscal Year 2024-2025. It is to assist the public in understanding the information being reported on the SACS forms.

The First Interim Financial Report shall reflect changes to the budget through October 31, 2024; the Second Interim Financial Report shall reflect changes to the budget through January 31, 2025.

For each interim report, the District must use the multi-year projections to certify one of the following:

- **Positive Certification:** The District WILL MEET its financial obligations for the current and two subsequent fiscal years.
- **Qualified Certification:** The District MAY NOT MEET its financial obligations for the current and two subsequent Fiscal Years.
- **Negative Certification:** The District WILL BE UNABLE TO MEET its financial obligations for the remainder of the current year or subsequent fiscal year based upon current projections (not meeting reserves in the current year or negative fund balance in any year).

Summary:

The District's General Fund for the 2024-2025 fiscal year is projected to have an overall operating deficit of \$1.16 million, with an ending balance of \$11.71 million (\$9 million for unrestricted activities). This represents an increased balance of \$1.27 million compared to the Adopted Budget. The primary factor contributing to the reduced expenditure is the decrease in overall salaries and benefits. This decrease reflects the inclusion of contractor positions in the payroll budget during the adoption of the budget. However, some positions in Special Education remained unfilled. To ensure the continued provision of quality education, we have allocated these unfilled positions to subcontracting in the FY 2024-2025 budget. In alignment with budget constraints, we have also reduced the services and other operating expenses within the unrestricted fund by \$491k.

Despite the deficit, the district is expected to maintain financial stability throughout the FY 2024-25 fiscal year and into subsequent years. Please refer to the Appendix for Multi-Year Projection detailed information.

It is recommended that the Board of Trustees approve a positive certification that our District will be able to meet its financial obligation for the current year and subsequent two years.

Financial Report Information:

The District's Budget and Accounting format are based on the California School Accounting Manual (CSAM) utilizing the Standardized Account Code Structure (SACS). Accounting is the fiscal information system for business. The District's accounting, referred to as Governmental Accounting is organized and operates on a fund basis. A fund is defined as a fiscal and accounting entity with a self-balancing set of accounts recording cash and other fiscal resources, together with all related liabilities and residual equities or balances, and changes therein, which are segregated for the purpose of carrying on specific activities or attaining certain objectives in accordance with special regulations, restrictions, or limitations.

General Fund (Fund 01): The General Fund is the chief operating fund for the District. It is used to account for the ordinary operations of the District. All transactions, except those required or permitted by law to be in another fund, are accounted for in this fund. The General Fund consists of unrestricted and restricted funds.

General Fund, Unrestricted: General Fund Unrestricted is to account for projects and activities that are funded with unrestricted revenues.

General Fund, Restricted: General Fund, Restricted, is to account for projects and activities that are funded by external revenue sources that are legally restricted or restricted by the grantor for specific purposes.

Local Control Funding Formula (LCFF) Revenue Sources (Object 8010-8099) \$25,041,159

LCFF revenue source represents 75% of the total General Fund Revenues. It is the prime revenue component of the District's total revenue sources. The projected ADA for FY 2024-25 is 2,033. This reflects an increase ADA of 62 compared to the Adopted Budget.

Federal Revenue (Object 8100-8299) \$747,429

Federal Revenue represents 2.2% of the total General Fund revenues. It includes funding for Special Education in the amount of \$447,482, Title I of \$195,194, Title II of \$40,152, Title III of \$52,100 Title IV of \$12,500. Federal Revenue reflects an increase of 4.6%, \$32k from the Adopted Budget due to mostly Title 1 adjustment.

Other State Revenue (Object 8300-8599) \$3,676,992

Other State Revenue represents 11% of the total General Fund revenues and includes Lottery Funding (Unrestricted/Restricted), Mandated Cost Reimbursement, ASES Program, STRS on behalf, Expanded Learning Opportunities Program (ELOP), Educator Effectiveness, Arts, Music and Instructional Discretionary Block Grant, Learning Recovery Emergency Block Grant and Special Ed Mental Health Funding. Other State revenue reflects an overall increase of 1.7%, \$59,968 from Adopted Budget. Most of the increase is attributed to the funding from Lottery allocation.

Other Local Revenue (Object 8600-8799); \$ 3,478,179

Other Local Revenue represents 10.44% of total General Fund revenues. The unrestricted revenue includes Interest Income, leased site revenue, and retiree reimbursement revenue. Restricted local revenue includes revenue from Parcel Tax Revenue, Millbrae Education Foundation, and local site donations and grants. Other Local Revenue reflects a decrease of \$436,297 compared to the Adopted

Budget, primarily due to reduced lease income, lower donations, and the removal of pass-through AB1209 funding in F01.

Transfers In (Object 8900-8929) \$370,391

This category is to account for the transfer from Fund 40 and Fund 20 to Fund 01. Transfers-In represents 0.3% of total General Fund Revenues. Transfers-In for the 2024-25 budget reflects no change at First Interim.

Certificated Salaries (Object 1000-1999) \$14,095,812

Certificated salaries represent 41% of the total General Fund expenditures; approximately 74% of the total certificated positions are funded by unrestricted funds and 26% of the total positions are funded by restricted funds. 2024-25 Certificated Staffing is projected at 130 FTE.

Classified Salaries (Object 2000-2999) \$5,019,078

The positions in this classification include but are not limited to Chief Business Official, Executive and Administrative Assistants, Administrative Secretary, Attendance Secretary, District Office Staff, Instructional Aide, Occupational Therapist, Special Ed Para Aide, Tutors, Behaviorist, Maintenance, and Operations Staff. Classified Staffing is projected at 80.13 FTE.

Employee Benefits (Object Code 3000-3999) \$ 8,097,820

Employee Benefits represent 23% of the total General Fund expenditures and consist of contributions to retirement plans including the State Teachers Retirement System (STRS) and the Public Employees' Retirement System (PERS), Health and Welfare benefits and payroll related statutory costs, including Workers Compensation, Social Security, Medicare and Unemployment Insurance.

Total Combined Salaries & Employee Benefits:

The total combined compensation (certificated, classified, and benefits) for the district is \$27,212,711 representing 79% of total expenditures. The district has unfilled positions in Special Education, so district outsources for those services to provide seamless education qualities. This expense has a budget amount around \$1,548,135 representing 4.5% of total expenditures. The true total combined compensation is \$28,760.845 reflecting 83% of total expenditures.

Books and Supplies (Object 4000-4999) \$906,834

Books and Supplies represent 2.6% of total General Fund Expenditures and consist of books, reference materials, other supplies and non-capitalized equipment (equipment less than \$5000). Books and Supplies has decreased by \$211,103 from Adopted Budget, which is mainly due to the budget adjustment per previous year spending.

Services and Other Operating Expenditures (Object 5000-5999) \$6,232,595

Services and Other Operating Expenditures account for expenditures from services, rentals, leases, maintenance contracts, dues, travel and conference, service agreements, insurance, utilities, legal, and other operating contracts and represents 18% of total General Fund Expenditures. Services and Other Operating Costs increased \$796,257 from Adopted Budget. The increase in the Adopted Budget is mainly due to professional consulting services and operating expenditures related to Special Education.

Capital Outlay (Object 6000-6999) \$92,303

This category accounts for any capital outlay expenditures over a cost of \$5,000.

Other Outgo-Transfers for Direct Charges (7100-7299, 7400-7499) \$124,764

Expenditures for Other Outgo for the District are those expenditures necessary to record payments for tuition, excess costs, and/or deficits paid to programs operated by the county superintendent of schools.

As a result of the changes indicated in both revenue and expenditures above, the 2024-25 First Interim General Fund Ending Fund Balance reflects an increase of \$1,271,806 from Adopted Budget.

MULTI-YEAR PROJECTIONS:

The Multi-Year Projection, a required component of the First Interim Budget, demonstrates the requirement that the District will meet its financial obligations in the current and subsequent two years. The Multi-Year Projection also indicates the District's ability to maintain the required 3% reserve for economic uncertainties for the current and subsequent two years. Enrollment and Average Daily Attendance is a major factor in multi-year projections.

The following are the projections and assumptions:

For FY2024-25, the District expects LCFF to increase by 2-3% due to increased ADA. Federal and State restricted revenue for FY 2024-25 is anticipated to increase by \$92k mostly due to increased lottery allocation and Title 1. Consequently, the General Fund balance is projected to be \$11.7 million.

Transitioning to FY 2025-26, the anticipated total revenue is similar to FY 2024-25, around \$33.2 million. Projected expenditures for FY 2025-26 are \$35.5 million, reflecting a 3% increase (\$1.04million) compared to FY 2024-25. Although the district expects a deficit during the MYP period, it is projected to meet the 3% State Reserve for Economic Uncertainties.

Fund 08- Student Activity Special Revenue Fund:

This fund is used to account for Associated Student Body funds and activities. ASB activities should be considered restricted because *Education Code (EC)* Section 48930 specifies that the purpose of ASBs is to conduct activities on behalf of the students for whom those funds are collected. It can be inferred that the funds are held for current students at the same school at which the funds were raised. In addition, *EC* 48933 indicates that the ASB funds should be expended subject to procedures established by the ASB.

Fund 13- Cafeteria Special Revenue Fund:

This fund is used to account separately for federal, state and local resources to operate the food service program (Education Code sections 38090 and 38093). The main revenues in this fund are:

- Child Nutrition Programs (Federal)
- Child Nutrition Programs (State)
- Food Service Sales
- Interest

The Cafeteria Special Revenue Fund (Fund 13) shall be used only for those expenditures authorized by the governing board as necessary for the operation of the LEA's food service program (Education Code sections 38091 and 38100).

Fund 17 - Special Reserve Fund for Other than Capital Outlay Projects:

This fund is used primarily to provide for the accumulation of general fund moneys for general operating purposes other than for capital outlay (Education Code 42840). Amounts from this special reserve fund must be transferred into the general fund first or other appropriate fund before expenditures may be made (Education Code Section 42842).

Fund 19 - Foundation Special Revenue Fund:

This fund is used to account for the resources received from gifts or bequests pursuant to Education Code section 41031 under which both earnings and principal may be used for purposes that support the LEA's own programs and where there is a formal trust agreement with the donor. Gifts or bequests not covered by a formal trust agreement should be accounted for in the General Fund.

Fund 20 - Special Reserve Fund for Postemployment Benefits:

This fund is used pursuant to Education Code section 42840 to account for amounts the LEA has earmarked for the future cost of post-employment benefits (OPEB) but has not contributed irrevocably to a separate trust for the post-employment benefit plan. Amounts accumulated in this fund must be transferred back to the general fund for expenditures (Education Code section 42842).

Fund 25 - Capital Facilities Fund:

This fund is used primarily to account separately for moneys received from fees levied on development projects as a condition for approval (Education Code 17620-17626 and Government Code Section 65995 et seq.) The authority for these levies may also be county or city ordinances (Government Code Sections 65970-65981) or private agreements between the LEA and the developer. Interest earned in the Capital Facilities Fund (Fund 25) is restricted to that fund (Government Code Section 66006).

The principal revenues in this fund are:

- Interest
- Mitigation/Developer Fees

Expenditures in Fund 25, Capital Facilities Fund, are restricted to the purposes specified in Government Code Section (65970-65981 or Government Code Section 65995 et seq., or to the items specified in agreements with the developer (Government Code Section 66006). Costs of justifying and adopting fees may be paid from Fund 25 (Education Code 17620). Administrative costs of collecting fees may be

reimbursed from Fund 25 within the limitations of Education Code Section 17620. Eligible expenditures incurred in another Fund may be reimbursed to that fund by means of an inter-fund transfer of direct costs.

Fund 40 - Special Reserve for Capital Outlay Projects:

This fund exists primarily to provide for the accumulation of general fund moneys for Capital outlay purposes (Education Code 42840). This fund may also be used to account for any other revenues specifically for capital projects that are not restricted to Fund 21, 25, 30, 35, or 49. Other authorized resources that may be deposited to the Special Reserve Fund for Capital Outlay Projects (Fund 40) are proceeds from the sale or lease-with-option-to-purchase real property (Education Code section 17462) and rentals and leases of real property specifically authorized for deposit to the fund by the governing board (Education Code Section 41003).

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates
