IPM STATEMENT

It is the goal of the Millbrae School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to:

- Focus on long-term pest prevention through approved Integrated Pest Management best practices
- Reduce the amount of pesticides used on school campuses

PEST IDENTIFICATION, MONITORING AND INSPECTION

Pest Identification is done by: Raul Fregozo, Maintenance Supervisor/District IPM Coordinator

Monitoring and inspection for pests and conditions that lead to pest problems are done regularly by the IPM Coordinator. Specific information about monitoring and inspecting for pests, such as locations, times or techniques include:

- Visual inspection for pests in common locations
- Communication with school site staff about recent activity
- Set monitoring stations and inspect weekly
- Quarterly school site inspections for pest prevention

HEALTHY SCHOOLS ACT

- School IPM training course approved by the Department of Pesticide Regulation (Education Code Section 16714; Food and Agricultural Code Section 13186.5).

SUBMITTAL OF PESTICIDE USE REPORTS

Reports of all pesticides applied by the school district staff during the calendar year, except pesticides exempt from record-keeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm (Education Code Section 16711)
